- **RE:** Fence Staining Guidelines

Dear Homeowners,

Several homeowners have reached out to your property management company (PCMS) and the District Manager for the metropolitan district requesting information regarding fence staining.

Guidelines are specifically for the homeowner's side of the fence.

...There are two basic causes for the appearance of Cedar products to change.

- (1) Ultraviolet Rays (Sun Fade) bleaching out the natural color
- (2) Chlorine from Irrigation bleaching out the natural color and causing white chlorine arches on the fence from the spray pattern.

## Cleaning:

Western Red Cedar is a soft wood that can easily be damaged by aggressive pressure washing, therefore one should use only <u>low to</u> <u>medium pressure</u> to clean the the surface of the wood.

Page 2, Cleaning cont'd

NOTE: always wash/clean the wood using a vertical motion.

The stain used on the exterior of your associations fence is;

...Sherwin-Willams Exterior Stain Woodscapes – Latex Flat – IFC 411XN (FOUNDERS VILLAGE SOLID) Custom Manual Match

Allow the wood to air dry for 24 to 48 hours before applying stain.

Application:

Spray Application yields the best aesthetic valve, and stain penetration into the wood fibers.

...1<sup>st</sup> Coat - Apply a liberal coat of stain to the fence Boards, Rails and Posts ...Back brush the 1<sup>st</sup> coat to ensure that all areas of the wood have been covered with stain.

...2<sup>nd</sup> Coat – Apply a light coat of stain to cover any brush marks of bare wood.

We hope this information is helpful to you as you prepare to beautify the privacy fences in your back yard.
