# CALL TO ORDER

Mr. Eames confirmed that all general disclosure statements have been filed on behalf of the members of the Board of Directors.

# OFFICER REPORTS RECORD OF PROCEEDINGS:

The first item of business was to review the June 14, 2022 record of proceedings. Upon final review, motion was made, seconded and with no public comment passed to approve the record of proceedings of June 14, 2022 as presented.

#### **FINANCIAL REVIEW**

The unaudited financial reports through March 31, 2023 were presented and reviewed by the Board. Upon final review and discussion, motion was made and seconded and with no public comment, unanimously passed to accept and file for audit the financial and delinquency reports for the months ending through March 31, 2023.

Mr. Mark Meadows and Ms. LeeAnn Roessler with Nolte Design were in attendance to provide updates on various open space construction and landscape projects, along with address inquiries from the floor and Board of Directors.

<u>New Clubhouse Facility</u>. Director Jenkins provided an update the construction activities/schedule for the second clubhouse/pool facility. Director Jenkins noted that the pool will probably not be open for the 2023 season, but the clubhouse facility portion of the project, could be open this coming Fall or early Winter.
